What is the overall deductible ?	\$3,000 individual / \$6,000 family. Co-insurance and co-payments do not apply to the deductible . This benefit combines your prescription drug and medical deductibles .	Generally, you must pay all of the costs from providers up to the deductible amount each plan year before this plan begins to pay. If you have other family members on the plan , each family member must meet their own individual deductible until the total amount of deductible expenses paid by all family members meets the overall family deductible . Your plan year: 01/01/2023 through 12/31/2023.
Are there services covered before you meet your deductible ?	Yes, preventive services and wellness drugs	This plan covers some items and services even if you haven't yet met the deductible amount. But a co-payment or co-insurance may apply. For example, this plan covers certain preventive services without cost-sharing and before you meet your deductible . What is the out-of-pocket limit for this plan ?	\$4,000 individual / \$8,000 family. Medical and prescription drug out-of-pocket limits are combined. Prescription drugs : \$1,500 individual / \$3,000 family.	The out-of-pocket limit is the most you could pay in a plan year for covered services. If you have other family members in this plan , they have to meet their own out-of-pocket limits until the overall family out-of-pocket limit has been met. What is not included in the out-of-pocket limit ?	Premiums, balance-billing charges, and health care this plan doesn't cover.	Even though you pay these expenses, they don't count toward the out-of-pocket limit .
